Dear Blair,

Thank you again for your time and input meeting with our YRA committee last night - it was much appreciated.

As discussed, I've prepared the following summary of what was agreed upon for your review:

“At a meeting with the YRA Committee on 26th January, 2015, Mr Blair Brewster, candidate for the Palmer United Party, agreed to all of the demands which we have been submitting to all candidates. Specifically, he agreed to:

1. push for a **dust monitoring station** to be installed ASAP and to **re-instate existing quarry green buffers**;
2. commit to bringing back **industry buffer areas, increased** to the level council has recommended;
3. push for **air quality testing** to be undertaken - starting ASAP and on-going, monitoring for odours, aerosols and *Aspergillus fumigatus* spores;
4. commit to **not supporting any funding for the Biomass Plant development at Yatala**, located as it is between populated suburbs on the western side of the M1 motorway.

Furthermore, with regard to the operation of existing quarries and industries in the Yatala/Ormeau area, Mr Brewster also promised to see

that **existing regulations (e.g. those supposed to restrict dust and odour production) would be enforced** and to pull up those found to be in breach. He said that he would fight for the rights of the people in this electorate, regardless of which party/parties end up with a majority after the election.”

What do you think? Does that cover the relevant points from last night's meeting?
